STUD CONTRACT

This stud contract certifies that the following bitch was bred naturally or inseminated with fresh chilled or frozen semen to the following stud owned by Jade East Shar-Pei under the following conditions:

The stud fee is non-refundable and is payable one half at the time of service and one half at the birth of the litter. Papers to register the litter with AKC will not be signed by the stud owner until the stud fee and any medical expenses incurred by the bitch have been paid.

Before the breeding takes place, the bitch owner will furnish evidence of the following to Jade East Shar-Pei: the bitch is over 18 months of age and not older than six years of age, either a preliminary hip evaluation if the bitch has not reached two years of age or a certification of hips that indicate no dysplasia if the bitch has reached two years of age, certification of no patella luxation, and if over two years of age certification of normal elbows.

If the bitch fails to whelp from this breeding or if the litter does not consist of two live, healthy puppies at eight weeks of age, a return service will be given at the above bitch's next season to the above stud, if this stud is still in our possession. If the above stud is not available for any reason, we reserve the right to mate this bitch with one of our other studs.

In the case of frozen semen the stud owner will furnish two straws of semen that will be shipped from the frozen semen storage facility to the veterinarian of the bitch owner's choice. Unless otherwise stipulated, if the bitch fails to conceive using frozen semen or if two live healthy puppies are not whelped, we reserve the right to breed this bitch with one of our other studs.

All charges resulting from the transportation of the bitch or expenses resulting from collection and shipping of fresh chilled or frozen semen must be paid for by the owner of the bitch. All medical expenses incurred by the bitch during the period she is being bred will be the responsibility of the owner of the bitch.

If the bitch changes ownership, right of return service is at our option.

Puppies resulting from this breeding may not be sold to unethical breeders, dog wholesalers or retailers, nor to any buyer where there is reason to believe the puppies will not receive proper care.

Puppies resulting from this breeding cannot be advertised or sold on social websites such as Facebook, E-Bay, Craig's List, or other internet sites other than the purchaser's own website.

The bitch owner agrees that the puppies resulting from this breeding will remain together until they are a minimum of 8 weeks of age. Puppies will not be separated from their siblings until after this age.

It is the opinion of Jade East Shar-Pei that only the highest quality and healthiest of a breed should be bred. Therefore on an individual puppy basis, without the agreement and written permission of Jade East Shar-Pei, puppies resulting from this breeding cannot be sold with breeding/show rights. Before selling a puppy resulting from this breeding with breeding/show rights, the owner of the bitch shall contact Jade East Shar-Pei and furnish the name of the person purchasing the puppy and any evidence requested by Jade East Shar-Pei proving that the puppy meets the requirements and standards set by Jade East Shar-Pei and is of a quality to be bred/shown. After an evaluation of the puppy, Jade East Shar-Pei, within ten days of receipt of evidence, will either submit written permission to the owner of the bitch that the puppy can be sold as breedable/show or cannot be sold as breedable/show.

The owner of the bitch shall include in their sales contract for puppies sold as pets that the puppy is sold without breeding/show rights and that the puppy will be neutered before the puppy reaches nine months of age. Where available, pet puppies will be sold with a limited registration.

If a purchaser of one of the puppies resulting from this breeding violates the agreement in the above two paragraphs, the owner of the bitch agrees to assist Jade East Shar-Pei in obtaining damages amounting to \$10,000.00. In the event that the owner of the bitch does not do so to the satisfaction of Jade East Shar-Pei, the owner of the above bitch is then liable for the \$10,000.00 damage fee indicated at the end on this contract.

The owner of the bitch agrees to be responsible for insuring that any puppies resulting from this breeding will not be placed in rescue, animal shelters, or in a home where the puppy will not be cared for. If at any time the purchaser of one of the puppies resulting from this breeding cannot keep the puppy, the owner of the bitch agrees to immediately take the puppy back to either keep it or find it a suitable home. The owner of the bitch agrees to include this in the sales contract for all puppies resulting from this breeding.

If this breeding takes place in the USA, the owner of the bitch agrees that, without the agreement of and written permission of Jade East Shar-Pei, puppies resulting from this breeding will not be sold to persons residing in Europe or South America.

If this breeding takes place in a country other than the USA, the owner of the bitch agrees that, without the agreement of and written permission of Jade East Shar-Pei, puppies resulting from this breeding will not be sold to persons residing in the USA.

If any term or article in this agreement is violated, due to the difficulty in establishing damages under the terms and provisions of this contract, the seller may seek damages in the amount of \$10,000.00. Purchaser agrees to pay all reasonable attorney fees incurred by the seller in enforcing stud owner's rights under this agreement. This agreement shall be governed by the laws in the state of South Carolina to the exclusion of any other forum and constitutes the entire agreement between parties. The bitch owner consents to the jurisdiction of the country and state in which the sire's owner resides in the event of any dispute arising from the above dog.
